**AS THE CDC CONTINUES TO UPDATE THE RECOMMENDED PRACTICES FOR PUBLIC SAFETY, THE CORN COB ACRES MANAGEMENT WILL CONTINUE TO MONITOR AND REVISE OUR PROTOCOLS.**

**THIS DOCUMENT OUTLINES SOME OF THE PROCEDURES AND PRECAUTIONS THAT CORN COB ACRES WILL PUT INTO PLACE DURING THE 2020 SEASON.**





# PRECAUTIONS TO PROMOTE THE SAFETY OF OUR VISITORS



THE CORN COB ACRES MANAGEMENT WILL CONTINUE TO MONITOR ANY DEVELOPMENTS IN SAFETY PROCEDURES RECOMMENDED BY THE CDC REGARDING GENERAL SAFETY, AND WILL MAKE ADJUSTMENTS AS NEEDED THROUGHOUT THE SEASON. ADJUSTMENTS WILL BE MADE AT ALL ACTIVITIES IN ORDER TO DECREASE THE NUMBER OF SURFACES THAT ARE TOUCHED BY MULTIPLE PEOPLE.



IN THE EVENT THAT CORN COB ACRES IS UNABLE TO OPEN DUE TO GOVERNMENT REGULATIONS, ALL TICKETS PURCHASED WILL ROLL OVER TO THE 2021 SEASON, OR THE OPTION FOR A FULL REFUND WILL BE AVAILABLE. PLEASE CHECK SOCIAL MEDIA AND OUR WEBSITE FOR CONSTANT UPDATES.



IT IS REQUESTED THAT VISITORS WEAR A MASK WHILE ON THE PROPERTY, ESPECIALLY IN AREAS WHERE THE ABILITY FOR SOCIAL DISTANCING IS RESTRICTED. (CHILDREN YOUNGER THAN 2 YEARS OLD SHOULD NOT WEAR A MASK IN ACCORDANCE WITH THE CDC)



IF YOU HAVE BEEN EXPOSED TO COVID-19 RECENTLY OR HAVE SYMPTOMS OF COVID-19 (INCLUDING A FEVER, COUGH OR SHORTNESS OF BREATH), PLEASE REMAIN AT HOME TO PREVENT THE SPREAD OF THE VIRUS.



WE WILL BE OPERATING AT 50% CAPACITY FOR THE 2020 SEASON IN ORDER TO BE ABLE TO MAINTAIN SAFE DISTANCING.





# ADDITIONAL PRECAUTIONS TO PROMOTE THE SAFETY OF OUR VISITORS



WE WILL CONTINUE TO MAINTAIN THE GENERAL CLEANLINESS AND SANITATION PRACTICES THAT HAVE ALREADY BEEN IN PLACE ON ALL AREAS OF THE PROPERTY. ADJUSTMENTS WILL BE MADE AT ALL OF OUR EVENTS IN THE PARK IN ORDER TO DECREASE THE NUMBER OF SURFACES THAT ARE TOUCHED BY MULTIPLE PEOPLE. ACTIVITIES THAT REQUIRE FREQUENTLY TOUCHED SURFACES WILL BE SANITIZED REGULARLY THROUGHOUT THE DAY.



TEMPERATURE CHECKS WILL BE PERFORMED ON CREW MEMBERS AND STAFF BEFORE THEY ARE PERMITTED TO GO TO THEIR POSITIONS.



WE HAVE PLACED NO-TOUCH HAND SANITIZERS AT MULTIPLE CONVENIENT LOCATIONS ON THE PROPERTY. ADDITIONAL HAND-WASH SINKS HAVE BEEN INSTALLED FOR THE 2020 SEASON. WE ASK GUESTS TO MAINTAIN HEALTHY PRACTICES SUCH AS WASHING HANDS REGULARLY AND USING HAND SANITIZER.



WE ARE REQUIRING FOOD VENDORS AND STAFF TO WEAR MASKS AND WASH THEIR HANDS/USE SANITIZER ON A REGULAR BASIS.



WE HAVE ADDED ADDITIONAL SIGNAGE AND GUIDES TO STRONGLY ENCOURAGE SOCIAL DISTANCING ON ALL AREAS OF THE PROPERTY. WE ASK THAT ALL GUESTS ADHERE TO THE INSTRUCTIONS ON SIGNAGE, AS WELL AS ANY INSTRUCTIONS GIVEN BY STAFF AND RECOMMENDED BY THE CDC.
